Option #1: BECOME A REALTOR®

Join as a "Primary" or "Secondary" Realtor®. Managing Broker will need to join in addition to applying member (or be an existing member).

- 1. **Primary** Licensed real estate agent or broker, or certified appraiser whose office holds membership in the Vail Board of REALTORS® (VBR is your main association of membership).
- 2. **Secondary -** Sole proprietor, partner, or corporate officer, branch manager in real estate or appraisal firm who holds **primary REALTOR® membership in another** Board/Association in Colorado. Will not pay CAR or NAR twice because it has been paid at Primary Board.

1) One Time Application Fees:

Application Fees are "One Time" if you remain a member of the Vail Board of Realtors®.

Option #2: MLS ONLY PARTICIPANT

To have MLS only access and not be a VBR member:

-Member must be a Primary Member of another Board in Colorado to be eligible for *MLS ONLY* membership. Also: Managing Broker must join with an agent (or be an existing member).
